Non – Resident Tamils – Art, Literature and Culture of Tamil Nadu - Formation of new Scheme for the Welfare of Non-Resident Tamil as per the press release delivered by Hon'ble Chief Minister of Tamil Nadu on 06.10.2021 – Rupees Four Crore Sanctioned as “Revolving Fund” – Opening of Personal Deposit Account in the name of Commissionerate of Rehabilitation and Welfare of Non – Resident Tamils – Orders – Issued.

## ORDER:

In the Press Release second read above, the Hon'ble Chief Minister of Tamil Nadu has made the following announcement for the Welfare of Non-Resident Tamils:

"புலம் பெயர்ந்துள்ள தமிழர்கள் அந்தந்த நாடுகளில் உருவாக்கியுள்ள நலச்சங்கங்கள் ஒருங்கிணைக்கப்படும். இச்சங்கங்களின் மூலமாக நம்முடைய கலை, இலக்கியம் மற்றும் பண்பாடு பரிமாற்றங்கள் நடைபெறும். இதற்காக ரூ.4 கோடி ஒதுக்கீடு செய்யப்படும்".

2. Accordingly, in the Government Order fourth read above, the Government have sanctioned Rs. 4.00 Crore (Rupees Four Crore only) as a "Revolving Fund" to implement the above scheme.

3. In the letter fifth read above, the Commissioner, Commissionerate of Rehabilitation and Welfare of Non-Resident Tamils has requested the Government to permit her to open a new Personal Deposit Account to deposit the above said amount and to utilize the amount for the above scheme.

4. The Government after careful examination accept the proposal of the Commissioner, Commissionerate of Rehabilitation and Welfare of Non-Resident Tamils, Chennai and accord permission to the Accountant General and to the Treasury Department to open a separate Personal Deposit Account in favour of the Commissioner, Commissionerate of Rehabilitation and Welfare of Non – Resident Tamils, Chennai – 5.

5. The Commissioner, Commissionerate of Rehabilitation and Welfare of Non-Resident Tamils is permitted to open a separate Personal Deposit Account in the name of Commissionerate of Rehabilitation and Welfare of Non-Resident Tamils, Chennai to utilize the fund of Rs.4.00 Crore sanctioned as "Revolving Fund" in the Government Order fourth read above for implementing the above scheme. The maximum amount of credit to the new Personal Deposit Account is Rs.4.00 Crore and the above Personal Deposit Account will be maintained at PAO (East), Chennai-5.

6. The Government also delegate the powers to the Commissioner (FAC), Commissionerate of Rehabilitation and Welfare of Non-Resident Tamils, Chennai to operate the above fund upto Rs.4.00 Crore (Rupees Four Crore only).

7. (a) The amount sanctioned in G.O.(Ms) No.200, Public (Rehabilitation.II) Department, dated 05.04.2023 shall be deposited in the Personal Deposit Account should be credited to:-

8. The Accountant General (Accounts- I), Chennai – 18 is requested to issue necessary authorization to the concerned officers to credit the Personal Deposit Account to the Commissioner (FAC), Commissionerate of Rehabilitation and Welfare of Non-Resident Tamils, Chennai – 5.

9. The Commissioner (FAC), Commissionerate of Rehabilitation and Welfare of Non-Resident Tamils, Chennai – 5 is requested to follow the instructions issued in the Government Order first read above strictly while operating the Personal Deposit Account.

10. The Commissioner of Rehabilitation and Welfare of Non-Resident Tamils is the Estimating, Reconciling and Controlling Authority for the above new heads of account.

11. This order issues with the concurrence of Finance (Pub) Department vide its U.O. No.28709/Fin(Pub)/2023, dated 25.08.2023.


